Job Title: Family Nurse Practitioner

Position Summary:

In collaboration with JAMPHCC Physicians, the Nurse Practitioner provides a broad range of primary health care services to patients of all ages. This includes performing physical examinations, developmental assessments, diagnosis, prescribing medications and treatments, ordering tests and x-rays, and offering referrals to physicians and/or other health care professionals as appropriate. He or she also is actively involved in shaping center policy and procedure and helping train clinical staff as necessary. We are looking for a hard working medical professional, committed to providing high quality team-based care to join our well established medical practice.

Qualifications:

Licensed as a registered nurse and officially recognized as a Nurse Practitioner by the State Board of Nursing for South Carolina. Nationally certified Family Nurse

Practitioner or Doctor's of Nursing Practice. Clinical primary care experience preferred, as well as an interest and willingness to teach NP students. CERNER EMR experience preferred.

Working Hours and Patient Load:

Full time clinical duties assumes 9 half days of patient care and 1 half day of in-office administrative time per week. Average patient schedule is 12 patients per half day for a mid-level provider. Some flexibility in scheduling is possible. No night time or weekend call coverage is part of the position.

Responsibilities:

1. Obtain medical histories and perform physical examinations.
2. Diagnose and treat common health problems such as infections and minor injuries.
3. Diagnose, treat, and monitor chronic diseases such as diabetes and high blood pressure.
4. Order and interpret diagnostic studies such as lab work and x-rays.
5. Prescribe or recommend prescriptions for medications and other treatments.
6. Provide family planning services and assist in early low risk prenatal care.
7. Provide well-child care, including screening and immunizations.
8. Provide health maintenance care for adults, including annual physicals.
9. Perform injections of vaccines and administer medications as needed.
10. Promote positive health behaviors and self-care skills through education and counseling.
11. Complete accurate and timely documentation of all services rendered.
12. Participate in clinical meetings and provide leadership to clinical staff.
13. Participate in quality reviews and policy reviews.
